

### HOW TO PERFORM THE SIX STEPS TO A PERFECT NOTARIAL ACT

#### REQUIRE PERSONAL APPEARANCE

- O Be Firm
- O Be Professional
- Suggest Alternate Time / Location
- Refuse to Perform Notarization
- Don't do "favors" for friends/family

## HOW TO PERFORM THE SIX STEPS TO A PERFECT NOTARIAL ACT

#### 2. REVIEW THE DOCUMENT

- ODetermine the type of document
- ODetermine who is supposed to sign & capacity
- ODetermine the type of notarial act to perform

#### 3. IDENTIFY THE PRINCIPAL

- O Goal: Match the name on document to person appearing to you
  - Personal Knowledge
  - Satisfactory evidence

#### EXERCISE 2

Your new co-worker, Drew Sample, asks you to notarize his car title which shows the owner's name as Andrew J. Sample. His Pennsylvania driver's license shows his name as Andrew Jason

Sample.

Can you use this ID for this notarization?


How should you enter his name on the notarial certificate?



You have been presented with a contract to be signed by Brenda Sample Nelson.

The person appearing to you is a middle-aged woman with dark brown hair, average height and weight who presents this driver's license:


She explains that she recently got married.



- Could you use this license in your state?
- What would you need to complete this notarization?

You work in a medical clinic and have been asked to take an acknowledgment of one of the doctors, Tina Armstrong Sample, who signed the document with her usual illegible scratch. You've worked there for several months and feel like you know all of the staff, including Dr. Sample, although you didn't know her middle name.

- Do you need to see her ID?

- How could you verify her middle name?




What name do you enter in the certificate?

#### 4. DETERMINE COMPETENCY & INTENT

- Actions speak louder than words pay attention
- Listen to what they say
- Verbally confirm willingness and intent

#### 5. COMPLETE THE JOURNAL RECORD

- Start journal entries early
- You enter details about transaction
- Have signer enter name and address






